



## Checklist for small planted woodlot on non-vulnerable land

<b>Part A - Can the operation be conducted under a Small Planted Woodlot FPP?</b>	<b>Yes</b>	<b>No</b>
1. Is the area to be harvested less than 10 ha for the property?	Go to 2.	Standard FPP required
2. Is the operational area only on non-vulnerable land and does not contain any land which is vulnerable land  Vulnerable land - (a) is within a streamside reserve or a machinery exclusion zone within the meaning of the <i>Forest Practices Code</i> ; or (b) has a slope of more than the landslide threshold slope angles within the meaning of the <i>Forest Practices Code</i> ; or (c) is within the High or Very High Soil Erodibility Class within the meaning of the <i>Forest Practices Code</i> ; or (d) consists of, or contains, a threatened native vegetation community; or (e) is inhabited by a threatened species within the meaning of the <i>Threatened Species Protection Act 1995</i> ; or (f) contains vulnerable karst within the meaning of the <i>Forest Practices Code</i> ; or (g) contains an area of trees reserved from the harvesting of timber or the clearing of trees under a forest practices plan where the period specified in the plan has expired; or (h) includes known Aboriginal sites as listed on Aboriginal Heritage Tasmania register.	Go to 3.	Standard FPP required
3. Will the operation have only minor roadwork and not involve the construction of new roads, quarries or the substantial upgrading of existing roads?	Go to Part B	Standard FPP required

## Checklist for small planted woodlot on non-vulnerable land

<b>Part B - Details to be included in the FPP for Small Planted Woodlots on Non-Vulnerable Land where relevant</b>	<b>Yes</b>	<b>No</b>
1. Is the land is under a PTR or does the owner wish to re-stock the land with trees?	Complete the reforestation section of the FPP	No action required
2. Does the operation involve more than one forest practice (harvesting, reforestation, related roading)?	Identify each discrete operational phase in the FPP	FPP for harvesting only
3. Will tree ferns be harvested?	Provide the following details in the FPP- - the name of the harvester - the estimated number of ferns to be harvested and - the period of harvesting	No action required
4. Has the landowner given consent in writing for the FPP to be submitted for certification?	Ensure landowner consent form is signed and attached to FPP before certification	FPP cannot be certified
5. Will the harvested timber be processed?	The name of the intended processor (where known) must be included in the FPP.	No action required
6. Will the FPP trigger a requirement to consult with local government (page 5 of the code) in relation to access onto local government roads?	Consult with local government and insert relevant provisions in FPP.	No action required for other issues on page 5 of the code
7. Are there any known natural and cultural values <sup>1</sup> that will require special management?	Include relevant provisions in the FPP	No further surveys or action required.
8. Will the harvesting and/or reforestation phase require an active fire and smoke management plan?	Include relevant provisions in the FPP	No action required

### **Part C – Specifications from the Forest Practices Code**

The FPP must contain the following statement: 'All persons must comply with the provisions of this plan and with the following sections of the Forest Practices Code, where applicable-

1. Section B – Building access to the forest (B1 to B7)
2. Section C – Harvesting of timber (C1.2 to C4.3)
3. Section E – Establishing and maintaining forests ((E1 to E2, E4)
4. Section F – Management of Fuel. Oils, rubbish and emissions (F1 to F3)

Note: The Standard Forest Practices Plan (FPP) template can be used. In drawing up the FPP any non-applicable sections in the FPP should be marked as N/A.
